- ✓ Attach three (3) written references from non-relative adults. Only one of these references can be from a teacher.

 - Do you think it is important to work, either at a job or as a volunteer, during summer vacation? Make sure to explain your answer.
 - In what service activities, either through school, community organizations, church etc., have you participated?
